

Report of the Nominating Committee - 2022

Wardens

When a Senior or Junior Warden is running for another term (they are allowed to serve up to three consecutive terms 1 year terms) the bylaws state that we do not need to solicit candidates to run against them.

Since both Casey and David are running for second terms, we did not call anyone to run for the wardens positions.

The bylaws state that we should make an effort to have two candidates for each open spot on the slate. We are not required to have two candidates for each slot. We are encouraged to work towards that goal.

Vestry

This year, we need to elect three people to serve 3 year terms on the vestry, and we need to elect an alternate.

The Nominating committee made 17 calls, asking folks to consider running for Vestry. We received the following responses:

- 7 - not this year
- 4 - no
- 2 - no response given
- 4 – YES

Unless there are nominations from the floor, all four candidates will be elected, with the candidate receiving the fewest votes standing as the alternate

Diocesan Convention Deputies

We need to elect four deputies to a 1 year term and an alternate.

The Nominating Committee made 6 calls and received:

- 1 – no
- 5 – YES

Unless there are nominations from the floor, all five candidates will be elected, with the candidate receiving the fewest votes standing as the alternate

Endowment Committee

We need to elect one person to a 3 year term, and one person to a 1 year term. The one year term is to finish out the last year for someone who was elected in 2020, but dropped off the committee due to health concerns. Manjula Hettiarachchi has been serving in that person's stead this year, but our bylaws say that an alternate only serves until the next annual meeting, when someone is elected to finish out the remainder of the open term.

We have two candidates running. Unless there are nominations from the floor, both will be elected with the candidate receiving the fewest votes serving the one year term.
